Dear Elementary School Parent:

The Rockdale County Public Schools (RCPS) strives to continue to help students stay physically and emotionally healthy during remote/virtual learning. As required by the Georgia Department of Education and the Georgia Mandate for Sexual Abuse and Assault Prevention Education, RCPS Health Teachers will teach instruction in the areas of human growth and development, adolescent sexuality, sexually transmitted diseases, and sexual abuse, assault, and exploitation prevention. The curriculum will present a strong program to students that abstaining from sex until marriage is the only sure way to avoid AIDS. The program will assist students in coping with social and peer pressures they face today. This will be done through the development of skills they can use in saying "no" to behaviors in which they do not wish to engage. These lessons are designed to be developmentally appropriate for the respective grade levels. This permission does not extend to younger students. Therefore, it is imperative that an adult is able to minimize and eliminate the risk of your students engaging in this instruction.

Growth and development are important and essential considerations in providing meaningful experiences for our young people. All pertinent concepts are presented in a logical, sequential manner beginning in kindergarten. As of August 2018, the Georgia Mandate for Sexual Abuse and Assault Prevention requires students enrolled in grades K-9 to annually receive age appropriate sexual abuse and assault awareness and prevention education. RCPS utilizes Kindergartners begin to associate that creatures of the same kind produce others of the same kind, middle school students are introduced to the correct anatomical terminology while identifying the physical and emotional differences between males and females, and high school students have experiences that will prepare them for parenting.

In addition, RCPS utilizes the *Think First & Stay Safe* curriculum in grades PreK-5. This child safety curriculum is research-based and has been scientifically evaluated and proven to help children stay safe. The *Think First & Stay Safe* program teaches students the importance of treating themselves and one another with kindness and respect. Through developmentally appropriate lesson plans, students learn about healthy relationship and personal boundaries. These interactive lessons allow children to better recognize appropriate vs inappropriate behaviors and use their critical thinking skills to make safe and healthy choices. Students whose parents support such education are much less likely to be bullied, abused or otherwise mistreated. The program provides a balanced perspective and keeps students engaged in learning vital safety strategies. Students are continually reassured that most people are kind and safe and can be counted upon, should the need for help arise. They learn to identify trusted adults in their lives and are encouraged to reach out and speak up when needed. What follows is a summary of the objectives to be addressed in the fifth grade growth and development unit of the Health Curriculum. Parent permission is required for your student to take part in this important unit.

- 1. Students will identify differences in the physical characteristics found among their peers.
- 2. Students will identify the role of the endocrine glands in puberty.
- 3. Students will describe the physiological and psychological changes that occur during puberty.
- 4. Students will describe the need for special hygiene measures during puberty.

Additionally, HIV/AIDS instruction is offered in alignment to the Center for Disease Control's Health Curriculum Analysis Tool. The purpose is for students to identify that HIV/AIDS cannot be contracted from casual contact with an infected person. This brief overview of HIV/AIDS is delivered during one lesson using Discovery Education's *HIV and AIDS: Staying Safe* documentary. **Additional parent permission is required for your student to participate in this instruction.**
